### Details pertaining to Affiliation of various courses for the Academic year 2021-22

Bengaluru City University invites applications for various types of affiliation for the academic year 2021-22 as prescribed in Sections 59 and 62 of the KSU Act, 2000, from the affiliated Colleges/Managements situated in the Bengaluru City University jurisdiction as specified in the Karnataka State Universities (Amendment) Act, 2015 i.e., Karnataka Legislative Assembly constituencies of Shanthinagar, Byatarayanapura, Yelahanka, Malleshwaram, Hebbal, Shivajinagar, Gandhinagar, Chamarajpet, Chickpet, Basavangudi, BTM Layout, Jayanagar and Rajajinagar

#### 1. RENEWAL OF AFFILIATION:

Applications are invited for renewal of affiliation to the existing courses, additional courses and enhancement of intake in the existing affiliated Colleges under the Faculties of Arts, Science, Commerce and Management and Education. The Colleges in tending to apply for renewal of affiliation/enhancement of intake to BHM, MBA, MCA should obtain prior approval of AICTE, for BASLP, MASLP or B.Sc./M.Sc. (Speech & Hearing) from Rehabilitation Council of India. For B.Sc-B.Ed, B.A-B.Ed. (integrated)/B.Ed./B.P.Ed/M.Ed. colleges from NCTE as applicable.

NAAC Accreditation: As per the State Government Circular No.76 UBV 2011 Bengaluru dated 17.05.2011 the Colleges which have completed 5 years are informed to adhere to the standards circulated by NAAC compulsorily and obtain a minimum of 'C'grade. The Principals of all the colleges have to make efforts toadhere to the directions of the State Government issued from time to time. Renewal of affiliation to such colleges for the academic year 2021-22 is subject for NAAC accreditation of 'C'grade.

## 2. AFFILIATION OF ADDITIONAL COURSE:

The Colleges can apply for affiliation for starting of additional courses under the Faculties of Arts, Science, Commerce & Management and Education. Colleges should seek affiliation to only approved combinations of UG courses.

For starting of P.G courses: Colleges having infrastructure facilities as per guidelines (available in the University website) for permitting post graduate courses in affiliated colleges are eligible to applyfor fresh affiliation to start P.G. courses. The Govt. Colleges should have prior permission from Dept. of Collegiate Education to apply for P.G.Courses. There is no need to submit separate application for P.G. courses.

### 3. ENHANCEMENT OF INTAKE:

The Colleges can apply for enhancement of intake to courses under the Faculties of Arts, Science, and Commerce & Management. In case of P.G. courses, colleges should note that they shall not seek enhancement of intake to P.G. course more than the intake fixed in the University P.G. Department of Studies as per the general resolutions of intake of courses at P.G. Departments has been given in the PG admission prospectus of Bengaluru City University which has already been posted in the University website.

# 4. FRESH AFFILIATION TO START A NEW COLLEGE:

The Managements/Societies /Trusts registered under Societies Registration Act/Trust Act, are eligible to apply for Fresh affiliation to start new Colleges (approved courses/combinations only) in the Bengaluru City University jurisdiction.

# 5. <u>PERMANENT AFFILIATION/CONTINUATION OF PERMANENT AFFILIATION</u> (EXCLUDING P.G. COURSES):

<u>Permanent Affiliation:</u> As per Section 62 of KSU Act 2000, the colleges affiliated to Bengaluru City University continuously for a period of not less than 5 years and fulfilling the conditions of affiliation and attained the academic and the administrative standards on an average stipulated by the University from time to time shall be eligible for grant of permanent affiliation. As per G.O.No. ED 37 UBV 2007 dated: - 09.04.2007, colleges must be accredited with 'C' grade by NAAC.

Renewal of permanentaffiliation: The colleges which have completed terms of Permanent Affiliation shall apply for renewal of permanent affiliation.

The colleges should submit application for Permanent affiliation/Renewal of Permanent affiliation and renewal of affiliation along with the prescribed affiliation fees.

The Govt. vide Circular No. ED 227 URC 2017 dated: 07-07-2017 have specified the period of permanent affiliation as 5 years, 4 years and 3 years for the colleges which have been accredited with A, B and C grade respectively by NAAC.

### 6. SHIFTING /CHANGE OF NAME/CHANGE OF MANAGEMENT ETC.,

Requests for Shifting of Colleges, Change of Name/Management, will be considered u/s 59(5) of the K.S.U. Act, 2000. Colleges willing to apply for the same should submit separate application, with copies of the relevant documents such as, a) Resolutions of the Governing Body/Trust of the colleges, b) Building plans, Sale/Lease deed, c) NOCs from other Departments, if any, etc., as required, along with prescribed fee.

Note: Colleges/Managements should note that the permission for Change of Name/Management etc., has to be approved by the State Govt.

#### 7. APPLICATION FEES:

- a. Renewal of affiliation (UG) and (PG)/ Additional Courses / Enhancement of Intake/Shifting / Change of name/Management /Enhancement of intake/B.Ed (Integrated)

The prescribed fees for various types of Affiliation has to be paid to the Finance Officer, Bengaluru City University in the form of Online/RTGS/NEFT/ Bank Transfer Account Number: 05190100016143 (IFSC Code: BARBOBANGAL) (one copy of fee payment receipt has to be submitted to the Finance Officer).

# 8. <u>AFFILIATION/APPLICATION FEE AND SUBMISSION OF APPLICATIONS:</u>

The affiliation fee as notified in the Notification (For SC/ST Colleges/Managements, affiliation fee payable is 50%, as per Government Order No. ED 21 UBV 2004 Bangalore dated:15-5-2004 has to be paid through RTGS/NEFT/ONLINE. in favor of Finance Officer Bengaluru City University.

The filled in application forms in all respects (along with Preliminary Project Report, in case of additional PG courses, if any) are to be submitted in person, in 3 sets with the documents/ RTGS/NEFT/ONLINE paid receipt towards affiliation/application fee Rs, 1000/- on or before 31-07-2021 and with (fee of Rs.1,000/- receipt towards affiliation/application fee Rs, 1000/- on or before 31-07-2021 and with (fee of Rs.1,000/- ap to 07-08-2021 (4.P.M.) at the 'Office of the Registrar (Academic penarty fees of Rs.1009/-) ap to 07-08-2021 (4.P.M.) at the 'Office of the Registrar (Academic penarty fees of Rs.1009/-) ap to 07-08-2021 (4.P.M.) Note: (1) Refund of Affiliation fee is as per therevised Statutes pertaining to affiliation of colleges/Institutions of Bengaluru City University.

- (2) Fee paid by the college towards in-eligible courses willnot berefunded /adjusted.
- (3) Colleges should mention Karnataka Legislative Assembly constituencies to which they belong in their applications with copies of relevant proof.
- (4) Additional 18% of GST on Affiliation fee shall have to be paid by the colleges as and when it is made mandatory by the Government.
