ELIGIBILITY FEES

Indian National who have passed the qualifying examination outside Karnataka shall pay the following **Eligibility fees** to the University at the time of counseling in addition to the regular fees.

Indian Nationals, Foreign Nationals and Non Resident Indians (NRI) who have passed the qualifying examination abroad (outside India) shall submit the Equivalence Certificate issue by Association of Indian University (AIU) along with the application to the University. The provisional Eligibility certificate will be issued on payment of the prescribed fee. The provisional /Eligibility certificate shall be obtained prior admission.

THE FOLLOWING SC/ST CANDIDATES ARE NOT ELIGIBLE TO CLAIM FEE REIMBURSEMENT

- (a) SC/ST students from other States
- (b) SC/ST students whose parents's annual income is more than Rs.2,50,000/-.
- (c) SC/ST candidates seeking admission to second PG course (Discontinued PG course is also taken into account).

The candidates shown at (a) (b) & (c) shall pay the prescribed Course & Examination Fees

I) **Cat-I, 2A, 3A & 3B and other students shall pay the prescribed fees.**



Cat-I candidates whose parent's annual income is less than or equal to Rs.250000/- (Rupees Two Lakh fifty thousand only) and candidates irrespective of Caste/Community/Religion, (2A 2C, 2D and others) who have studied for period of 7 (Seven) academic year (commencing from 1st std. up to the qualifying examination either continuously or in broken period) and whose parent's Annual income is less than or equal to Rs.1,00,000/-(Rupees One Lakh Only) are eligible to claim the reimbursement of Tuition Laboratory, Library, Sports and Examination fees. The reimbursement of fees will be credited by the Backward Class Welfare Department(BCWD) only to such students who are eligible as per the norms of Government of Karnataka www.karepass.cgg.gov.in; of the BCWD.

II) The candidates belonging to minorities (i-e., Muslims, Christians, Buddhists, Sikhs, Anglo-Indians, Jains, Parsi etc.,) whose Parent's Annual Income is less than 48,950/-(Rupees Forty Eight Thousand Nine Hundred Fifty Only) are eligible to apply for Encouragement Fund/Fees reimbursement from Minorities Welfare Department (MWD) as per the norms of MWD.

Note: The Scholarship amount for SC/ST Cat-1 Students where parental income is equal or less than 2.5 lakhs per annum which is released to the students bank account directly through DBT (Direct Beneficiary Transfer) Scheme by the state Government. Hence student opted for admission for the year 2022-2023 has to pay full amount related to admission fees as well as Examination Fee and claim reimbursement by applying through SSP Portal
