In this regard, the following procedures are to be followed.

- (a) After declaration of results, if any candidate wishes to apply for Revaluation may do so within the dates as mentioned below by visiting UUCMS PORTAL (b) Then click online payment. link will be connected to Student Portal (c) Then Student has to select Revaluation

option. (d) Then the paper code details will be displayed. Student has to select the number of papers for Revaluation. (e) Then click on pay fee button to get payment option. (f) Now students can pay by UPI/Credit/Debit Card and Net banking. (g) After successful payment receipt will be generated.

2. There is No challenge valuation for UG Courses.
3. Fees once paid for Revaluation will not be refunded or adjusted for future Examinations.

Procedure for applying Revaluation:


01. Students should login with their (UUCMS) Login Credentials.
02. Click on the “Exam application” to View the results in the Student Portal.
03. Click on the Exam > “Exam Re-evaluation” tab who desire to apply for Revaluation and Photocopy.
04. Prescribed fee will be displayed in the portal itself for each Subject
05. Students should select the subjects for which they desire to Apply for Revaluation and Photocopy.
06. Select the Payment type and Click on the Pay fee button to Submit the Application Form.
07. A unique Application number will be generated Students should take the print out of the Application Form for further correspondence.

Note: Strictly No Manual Application will be entertained.
