ELIGIBILITY FEES

Indian Nationals who have passed the qualifying examination outside Karnataka shall pay the following *Eligibility Fees* to the University at the time of counseling in addition to the regular fees.

Indian Nationals, Foreign Nationals and Non Resident Indians who have passed the qualifying examination abroad (outside India) shall obtain and submit the Equivalence Certificate issued by Association of Indian University(AIU) along with the application to the University to their which provisional Eligibility certificate will be issued by the University on payment of the prescribed fee. The provisional Eligibility certificate shall be obtained prior to admission.

FEES PRESCRIBED FOR FOREIGN NATIONALS & NRIs

The Foreign Nationals and NRIs shall pay US \$ 2178/- as annual fees in addition to Eligibility fees for various courses.

Fees once paid will not be refunded

THE FOLLOWING SC/ST CANDIDATES ARE NOT ELIGIBLE TO CLAIM FEE REIMBURSEMENT

- (a) SC/ST students from other States.
- (b) SC/ST students whose parents' annual income is more than 2,50,000/-.
- (c) SC/ST candidates seeking admission to second PG course (Discontinued PG course is also taken into account).

The candidates shown at (a), (b) & (c) shall pay the prescribed Course & Examination fees.

I) Cat-I, 2A, 3A & 3B and other students shall pay the prescribed fees.

Cat-I candidates whose parents' annual income is less than or equal to Rs.2,50,000/- (Rupees Two Lakh fifty thousand only) and candidates irrespective of Caste/ Community/ Religion, (2A, 3A, 3B and others) who have studied for a period of 7 (Seven) academic years (commencing from 1st std. upto the qualifying examination either continuously or in broken period) and whose parents' Annual income is less than or equal to Rs. 1,00,000/- (Rupees One Lakh Only) are eligible to claim the reimbursement of Tuition, Laboratory, Library, Sports and Examination fees. The reimbursement of fees will be credited by the **Backward Classes Welfare Department (BCWD)** only to such students who are eligible as per the norms of Government of Karnataka www.karepass.cgg.gov.in; of the BCWD.

II) The candidates belonging to **minorities** (i.e., Muslims, Christians, Buddhists, Sikhs, Anglo-Indians, Jains, parsi etc.,) whose Parents' Annual Income is less than 48,950/- (Rupees Forty Eight Thousand Nine Hundred Fifty Only) are eligible to apply for Encouragement Fund/ Fees reimbursement from **Minorities Welfare Department (MWD)** as per the norms of MWD.

NOTE: The Scholarship amount for SC/ST/Cat-1 Students where parental income is equal or less than 2.5 lakhs per annum which is released to the students bank account directly through DBT (Direct Beneficiary Transfer) Scheme by State Government. Hence student opted for admission for the year 2020-2021 has to pay full amount related to admission fees as well as Examination Fees and claim reimbursement by applying through SSP Portal.
